Voluntary Group Accidental Death & Dismemberment Insurance



Broward County Professional Paramedics & Firefighters Benefit Fund

ELIGIBILITY

Employees: Each Active, Full-time employee working 30 or more hours per week, except any person working on a temporary or seasonal basis.

BENEFIT AMOUNT

Employee:

Choose from a minimum of \$10,000 to a maximum of \$500,000 in \$10,000 increments (not to exceed 10 times Earnings for amounts over \$150,000)

Spouse and Child(ren):

Dependent: Family coverage is available as a package based on the following percentages of your benefit amount:

Spouse only: 50%

Spouse: 40% ; Child(ren): 10% per child

Child(ren) only: 15% per child

Dependents:

You must be insured in order for Dependents to be covered. Dependents are:

- your legal spouse who is not legally separated or divorced from you [or your domestic partner].
- your unmarried financially dependent child(ren)*, to 26 years who is either: (a) a full-time or part-time student; or (b) living in your household.

* natural and adopted children; stepchildren and foster children in your custody

A person may not have coverage as both an Employee and Dependent. Only one insured spouse may cover Dependent children.

“Member” means hand, foot or eye.

Coverage is 100% employee paid.

EXCLUSIONS

Benefits will not be payable for any loss: to which sickness, disease, or myocardial infarction, including medical or surgical treatment thereof, is a contributing factor; caused by or resulting from war; caused by an accident that occurs while in the armed forces of any country; caused by or resulting from: piloting any aircraft; or riding in or getting into or out of any non civilian aircraft or any aircraft owned, leased or operated by you or any of your employers; sustained during the insured's commission or attempted commission of an assault or felony; to which the insured's acute or chronic alcoholic intoxication is a contributing factor; or, to which the insured's voluntary consumption of an illegal or controlled substance or a non-prescribed narcotic is a contributing factor.

For a comprehensive list of exclusions and limitations, please refer to the Certificate of Insurance. The Certificate also provides all requirements necessary to be eligible for coverage and benefits.
